		2.	ABC - type fire extinguishers in place and in working order (annual inspections). All cabin users trained in proper extinguisher usage: (PASS – (P) pull out the pin; (A) aim the extinguisher; (S) squeeze the handle; and (S) sweep side to side at the base of the fire.  Notes:
		3.	Smoke detectors in working order and strategically placed.  Notes:
		4.	Flashlights in working order and strategically placed.  Notes:
		5.	Safe egress routes identified for all areas of the cabin.  Notes:

		6.	Fire emergency phone numbers posted by each telephone. (Warm Lake Emergency Numbers Magnetic Card available from the Fire Committee).  Notes:
		7.	Fireplace and chimney inspected and free of creosote. Note: Damp/green wood and colored paper accelerate creosote buildup.  Notes:
		8.	Wood stoves and fireplace inserts meet county standards and codes.  Notes:
		9.	Stacked firewood and flammable debris at least 30' from the cabin.  Notes:
		10.	All propane tanks clear of flammable debris (grass, weeds, etc.).  Notes:
		11.	Roof, eves and gutters clear of needles, etc.  Notes:
		12.	Tree branches trimmed away from chimney and roof and 15' off the ground. Power lines need 15' vertical clearance.  Notes:
		13.	Spark arresters inspected and in good condition (check in spring after the winter snow).  Notes:
		14.	Lot clear of dead trees, pine needles or other flammable debris within 30' of the cabin or outbuildings. Wood cutting permit may be required.  Notes:
