On May 21st the county commis-

sioners of Blaine County, Idaho officially banned jet-skis on two of its mountain lakes. Jet-skis will no longer be allowed on Alturas and Petit Lakes effective immediately. Petit Lake is very similar in size to Warm Lake. Hopefully this decision will provide the Valley County commissioners with a precedent proving that banning jetskis does not lead to lawsuits nor does it adversely affect the
